Artist will deliver all art to be considered by the time listed on the Form. 2. BCA agrees to treat art in its care with care but Artists holds harmless BCA its employees, volunteers and guests, for loss, theft and/or damage of art in its possession. 3. Artist agrees to retrieve art not chosen by the jury on the retrieval date outlined in Form. 4. Artist agrees to allow BCA to display all art chosen by the jury at the Biz Center Art gallery for the duration of the show as outlined in the Form. 5. BCA may sell any art not designated "NFS" for the price listed on the Form. 6. Artist agrees to retrieve art not sold during the run of the show by the second retrieval date listed on the Form. 7. BCA will retain a 35% commission on the sale of any painting sold during the show and pay Artist 65% of the sale price of the art listed on the Form. 8. This contract will be carried out pursuant to the laws of the state of California. 9. Should any dispute arise due to this contract, both parties agree to binding arbitration.
